MA General Laws mandate an Annual Street Listing each year, which provides proof of residence to protect voting rights, burial rights, veterans' bonus, school admission, enrollment verification, housing for the elderly, and it is important information for your community's funding, town services and related benefits as well as providing information for the selection of jurors. This form DOES NOT register you as a voter and may not be used to change party affiliation.

GENERAL INSTRUCTIONS: Please PRINT all Entries.

- 1. Verify and/or complete all information listed on the form. If changes are required, enter directly below preprinted information. Sign form under the Penalties of Perjury as prescribed by MGL Ch. 56 §4 and return immediately.
- 2. List ALL family or household members in dwelling unit. Include any member of the family in Military Service, away at school and persons confined to nursing/rest homes who claim this as their legal address.
- 3. Use blank lines for NEW residents including all pre-school children.
- 4. Cross off resident no longer residing at this address and provide new address or indicate if deceased. If the resident you are removing is a registered voter, we need that person's signature in order to remove from our census and voter list. If we do not know your birthday, it may appear as 07/04/1776 and MUST BE UPDATED.
- 5. OCCUPATION Enter job performed, not place of employment. If a student, list school and grade: School = Wahconah Regional, Nessacus Middle, Craneville, St. Agnes, Pittsfield High, Taconic High, Home Schooled, College, Other. Grade = Nursery, Preschool, Kindergarten, Actual Grade, Ungraded.
- 6. PUBLIC SAFETY Check this box if you are a Public Safety Officer AND work in Dalton.
- 7. VETERAN Check this box if you are a United States Veteran AND list war.
- 8. 'To return this form, tri-told and insert into return envelope provided, add postage and mail, or deposit into the Town Hall drop box located at the handicap ramp on the South Carson Avenue side of the building, or deliver to the Town Clerk's office WITHIN 10 DAYS OF RECEIPT.

DOG LICENSES ARE DUE JANUARY 1 OF EACH YEAR

Dog licenses expire December 31, 2018. You may license your dog(s) in person at the Town Clerk's office or, for your convenience, you may fill in the enclosed form and return it with your check payable to the Town of Dalton along with a stamped, self-addressed return envelope and your dog's current rabies certificate and proof of altering if not already on file. Place in the drop box at the Town Hall, located at the handicap ramp on the South Carson Avenue side of the building, or mail to the Town Clerk. Your Certificates will be returned to you.

A \$10 per dog late fee is imposed February 1 and a \$50 per dog failure to license Citation is issued April 1 to owners of all unlicensed dogs.
