Dalton Police Department License to Carry and FID Card Applicants

Class A License to Carry -

- Must be at least 21
- Safety Class required for new applicants, active Military are exempt with Identification
- A LTC Class A entitles the holder to possess a large capacity firearm (pistol or revolver), rifle or shotgun.
- \$ 100.00 check or money order made Payable to the Town of Dalton
- Renewals over 70 are free

FID (Firearms Identification Card)

- Must be at least 15 years old with Parental Permission
- For applicants under 18, Parent must be present at time of application processing
- Safety Class is required for new applicants, active Military are exempt with Identification
- A FID entitles the holder to possess non-large capacity rifles and shotguns.
- \$ 100.00, Renewals over 70 are free, \$ 25 for applicants under 18 check or money order, made Payable to the Town of Dalton

FID - Restricted, Pepper Spray and/or Mace

- Permits are no longer needed for individuals over 18
- Under 18 must still have a permit
- Firearm License Processing is completed by the Police Administrative Assistant Monday through Fridays 10 a.m. to 3 p.m. or by appointment at the convenience of the Police Administrative Assistant, at this time fingerprints, if applicable, and pictures will be taken.
- As a result of the enacting the Massachusetts Gun Control Act of 1998, for the purposes of firearms licensing, any and all previous, detentions, arrests, court appearances, juvenile adjudications, including any "Sealed records will be assessed and considered in order to determine the statutory eligibility and suitability of all applicants for licenses to carry and possess firearms. You must disclose any and all appearances in court as a defendant regardless of the outcome of the case, i.e. continued, dismissed, guilty, or not guilty. Failure to disclose you appeared as a defendant can be a reason to deny the issuance of first-time applicant or renewal. Honesty counts as a background check and suitability.
- * ALL First time License to Carry (LTC) AND applicants upgrading from a FID to a LTC Permit MUST complete either a state approved basic firearms safety course or Massachusetts Hunter's Education Class, after September 14, 2004, pursuant to Mass. General Law Chapter 131 section 14, before receiving your LTC or FID.
- ❖ Effective 1/1/2015, All renewal applicants must sign Massachusetts LTC /FID Card Affidavit regarding stolen or lost firearms. (Affidavit is attached to application)
