Town of Dalton By-Law, Chapter 200 Peddling and Soliciting

Attached is the registration application for peddling, soliciting or canvassing in the Town of Dalton. All applications must be filled out completely and submitted, with a check in the amount of \$ 50.00 payable to the Town of Dalton, to the Chief of Police of the Dalton Police Department. If your application is missing any information or if the fee is missing your application will be considered incomplete and disregarded.

***If you have been issued a state Hawkers and Peddlers license please provide the Dalton Police Department with a copy upon application. ***

The application will be reviewed by the Chief of Police for approval. Approval shall be made within seven (7) days in the case of an **Individual Registration**, or, three (3) days in the case of an **Organizational Registration**. At that time the Chief of Police shall furnish to each person engaged in the peddling, soliciting or canvassing a registration card containing the person's name, photograph, organization represented and expiration date of the permit. Registration cards shall always be in the possession of the canvasser, solicitor or peddler when engaged in their activities.

Registrations are valid for up to 30 days. Hours of soliciting, canvassing or peddling are from 9:00 a.m. to 7:00 p.m. unless otherwise specified.

All applications will be kept on file at the Dalton Police Department.

Attached is a copy of Town of Dalton By-Law, Chapter 200, sections 7 and 8, explaining the duties and restrictions of canvassers, solicitors and peddlers. Any violation of these two sections shall be punishable by a maximum fine of \$300 and the revocation of registration for peddling, soliciting or canvassing.
